## Child Safe Organisation

Q: Confirm the camp provider is a child safe organisation under the NSW Child Safe Scheme

A: YES. -Inspiring Hope is a child safe organisation and registered under the NSW Children's Guardian safe Scheme. All Staff and Volunteers require WWCC.

## Mandatory Reporting

Q: Are camp staff are aware of their mandatory reporting obligations.

A: YES -Inspiring Hope abides by the mandatory reporting obligations and requirements of the risk of significant harm (ROSH) with the (MRG) via the e-Reporting Child Story.

## Supervision

Q: What Measures taken to ensure supervision at all times of CYP.

A: YES -Inspire Girls camp team consists with 6 full time staff who will always ensure supervision. Teams consist of 15+ mentors who are trained volunteers with their screened WWCC .

## Ratios

Q: What is the ratio of camp leaders to CYP

A: RATIO- Our intentional supervision and ratio of leaders to CYP during the camp program is  
- 1 Mentor to x 4 YP participants.  
- Upholding all P&P of Child Safety requirements.

## Sleeping Arrangements

Q: What ensured restricted access to rooms and supervision

A: Rooms are locked during the day to ensure safety. During the night our mentors are roomed next door for any additional night time support.

## Sleeping Arrangements

Q: How do camp oversight organise sleeping arrangements and room sharing .

A:- Our Camp oversight will allocate CYP based on ages and behaviour support needed.  
- 8 CYP in one cabin/room with 2 Mentor supports next door in the cabin/room for sleeping arrangements.

## Access to phones/ Safe Person

Q: Are CYP supported to get in phone contact with a safe person such as caseworker or carer if they are wanting it.

A: YES. -Our Wellbeing Behaviour support staff will assist at any time the CYP is wanting to make a call to their case worker/carer if needed. As per the registration submission.

## Access to phones/ Safe Person

Q: Are personal mobile phones allowed to be used by the children during the camp.

A: YES -access to phones for 1 hour a day under supervision in a controlled safe environment. (Please request SOP if needed)

## Information Sharing

Q: Are Camp coordinators aware of CYP's strengths, needs, diagnosis and behaviours and supports in place

A: YES -Inspiring Hope's registration process includes BSP and wellbeing case notes. Our registration form is detailed for any supports that are previously in place to help support during the week. We ask for any safety plans, wellbeing plans or BSB prior to camp for support with our "wellbeing Behaviour Support Worker"
